

Does Your Company Have a Matching Funds Program? (Not sure? Look below!)

Do you know whether your company offers a matching donation program, and if it includes tax exempt 501(c) (3) organizations. If it does, your donation to Our Lady of Mercy can be easily doubled!

That means every \$25 donation you made becomes \$50 for OLM. Here's something even more interesting. Did you know that some companies will "match" your donated time with dollars?
