## ***Does Your Company Have a Matching Funds Program? (Not sure? Look below!)***

Do you know whether your company offers a matching donation program, and if it includes tax exempt 501(c) (3) organizations. If it does, your donation to Our Lady of Mercy *can be easily doubled!*

That means every \$25 donation you made becomes \$50 for OLM.

Here's something even more interesting. Did you know that some companies will "match" your donated time with dollars? In other words, if you volunteer here at OLM, your employer will convert those hours to dollars and provide a check to OLM to match your efforts.
